EURO Management Science Strategic Innovation Prize (MSSIP 2009)

Call for proposal of area of application

The European Association of Operational Research Societies (EURO) is offering an award to foster specific areas of application of Operational Research in management. The prize is intended to award outstanding contributions in theory or in practice of a given area. This area is announced several years in advance to encourage innovative researchers and possibly entire research groups to focus their work on a domain of particular strategic interest.

The award, sponsored by SAP AG, Walldorf, Germany, will be called Management Science Strategic Innovation Prize (MSSIP) and is endowed with an amount of 12.000 EUR.

Proposal of area of application

The proposal of area of application should take into account the points here under:

- Name of area, description of area, emphasizing its strategic significance
- Already existing related research
- People already working in the suggested area
- Possible chair person of the jury

Please send your proposal of area of application to: President@euro-online.org and to Office@euro-online.org

Comments:

- The area should be comparatively broad and of strategic importance. It should usually not be a traditional area of Operations Research but a field to which OR could contribute to a major advancement. The area description and the possible OR contribution should be sufficiently specific. It should have the format, e.g., of a call for papers for a special workshop, or a focused issue of a journal.
- The literature survey should particularly indicate how OR could contribute to an advancement of the area. Hence non-OR literature might be mentioned as well.
- Not only people, but also workshops and other initiatives (possibly non-OR related) should be mentioned as well. It is not necessary (and even not desired) that all these people have an OR background.
- The suggested chairperson should be an OR scientist.

The IFIP TC8/WG8.3 conferences present the latest innovations and achievements of academic communities on Decision Support Systems (DSS). These advances include theory, systems, computer aided methods, algorithms, techniques, and applications related to supporting decision making.

This conference is supported by the Euro Working Group on DSS (see http://www.euro-online.org/).

The main theme for the 2008 edition of the conference is Collaborative Decision Making and in particular, addressing the question of how to support Collaboration in Decision Making? Welcome answers will incorporate key elements to deal with the complexity of supporting collaborative decision making. Expected contributions will try to answer to some of the following questions: Where does the data for collaborative decision making come from and how is it assembled? Who is, or should be, involved in making the decision? How do teams collaborate to build up common understanding? How to Tackle Complexity in decision making and decision support? A special focus on Data, Models and Actors will be taken into account.

Topics: The topics of interest for the conference include, but are not limited to:

- Facilitation of team coordination and data collection and exchange
- Logistics knowledge collaboration model
- Impact of introducing new technology on collaboration
- Spontaneous collaborations
- Evaluation of the most appropriate collaboration level
- Coordination of distributed supply chain partnerships
- Machine intelligence coupled with human intelligence
- Collaboration across supply networks using intelligent agents
- Knowledge-intensive collaborative design
- On-demand business process-based collaboration
- Utilizing context in knowledge management and collaborative systems
- Collaboration among entities in a network such as schedulers
- Social collaboration systems
- Intellectual capital as a resource network for collaborative decision making.

Papers focused on other areas linked to DSS area are also welcome, for example:

- Data-driven DSS (including data mining types of problems)
- Model-driven DSS
- Intelligent DSS
- Real-time DSS

A Doctoral Colloquium will be held as part of the conference July 1st 2008 is organised by G. Philips-Wren and D. Paradice.

Submissions

Each paper will be reviewed by at least two referees. Accepted papers will be published only if at least one of the authors is registered to attend the conference in due time. Accepted papers with at least one registered author will appear in the Proceedings of the Conference published as a book. Formatting Instructions for submissions will be delivered in the second Call for Papers. Best papers will be forwarded for submission to several special issues for high level journals in the DSS area like Journal of Decision Systems, Intelligent Decision technologies, European Journal of Operational Research (EJOR).

Robust Multiobjective Design Optimization with Simulation

The subject of this workshop is robust optimal design where simulation is an important part of the design evaluation, and where there may be more than one objective function. The workshop aims to gather people from different fields, primarily from the Nordic countries, within academia and industry to discuss the state-of-the-art and future challenges in solving these problems. We hope that stimulating discussions across subject boundaries will enrich us all.

The talks will be given in English. International Symposium on Health Informatics and Bioinformatics (HIBIT'07) was held in Belek, Antalya, Turkey in April 30 - May 2, 2007. It was the second HIBIT conference organized by Informatics Institute, Middle East Technical University (METU), Turkey. The aim of **HIBIT'07** was to bring together academicians from medical, biological, and IT fields with industry and government for creating synergy and supporting interdisciplinary research and development in the region on the subject.
